## **CONDITIONS OF RENTAL AGREEMENT WITH LIABILITY COVERAGE**

- 1. Rental Rate for <u>Parishioners</u> Without Bar \$200 or <u>Non-Parishioners</u> Without Bar \$300
- 2. Additional Payment if you need BAR: 1-25 People \$135, 26 100 People \$216, 101- 140 People \$270
- 3. No gambling is permitted rented areas are subject to supervision during rental period.
- 4. Rented areas are to be vacated and left in the same condition prior to rental. \$100.00 deposit is required and will be returned if the hall is left in a satisfactory condition following an inspection.
- 5. Restitution for any damage to St. Anne parish Centre (facilities or any rental equipment to include appliances, tables, chairs, dinnerware, cutlery etc.) is the responsibility of the Lessee.
- 6. No confetti or similar substance will be used in or around the premises if used a fine will be charged to the Lessee.
- 7. Decorations: pictures, tacks, tape, nails etc. are not allowed on walls or ceiling, If used damages will be charged to the Lessee.
- 8. All candles must be enclosed or contained in glass (fire code) candelabrum, single candle sticks or open flames of any kind are not allowed. (fire code)
- 9. The purchase and sale of alcohol shall be the sole responsibility of the St. Anne Knights of Columbus council. Bar prices are Alcohol/Beer \$4.50 & Pop/Water/Juice \$1.00
- 10. No alcohol is to be taken outside the hall at any time, and no alcohol will be allowed into the premises, which is a violation of the liquor provincial laws.
- 11. Any alcohol to be used as prizes or raffles is to be given to the bartender until the end of the function.
- 12. Certificate of Insurance will be obtained by the parish, naming "St. Anne Parish Centre and St. Anne Knights of Columbus Council" (if alcohol involved).
- 13. All persons are to vacate the premises no later than 1: 00 am
- 14. Payment due upon signing of contract (or) prior to key pick up. Make cheque to St. Anne Parish
